## HAMILTON COUNTY BOARD OF ADJUSTMENT MINUTES TUESDAY 5/28/19

The Hamilton County Board of Adjustment held a public meeting on May 28,2019 at 8:00pm at the 4-H Building, Hamilton County Fairgrounds, Aurora, NE.

Scott Stuhr, Administrative Manager, called the meeting to order at 8:02 pm, stating that the open meetings act was posted at the table with the sign in sheet, and is available for public inspection.

\*Mr. Sullivan spoke for the Harvey family. He hopes for a compromise in front of a possible litigation. He spoke of washout/lagoon litigation across the state of Nebraska. Mr. Sullivan asked the public to raise their hands "Who doesn't want the lagoon where it is?" All raised their hands except 1 who stated he was neutral.

## Public comment:

Mrs. Pat Anderson asked about pipe memorandums would to have been approved by the county board. The odor affects her home and quality of life.

Mr. Wall, stated this spring there was a leak on O road. It was fixed a couple times and last fall the sprinklers were running and spraying the road and washing down the road and ditch towards the creek.

Mrs. Joan Pfeifer stated she liked the development but now will not use 9<sup>th</sup> Rd due to the smell. Now this is getting closer and closer to our homes and concerning.

A gentleman asked if the Corps of Engineers were contacted about boring under the Beaver Creek? (Scott Stuhr stated that the Corps was contacted and approved).

Mr. Doug Anderson asked with all this rain, surely no one will shut down this truck wash all while DEQ watches this happen.

Mr. Patrick Harvey spoke. He spoke with DEQ

Mr. Todd Hansen stated that property values will begin to diminish and why was no one contacted in the area?

Todd Joyce spoke that he had to tell DEQ where the pit is. He is also concerned that the lagoon is not lined.

Scott Stuhr, Hamilton County Administrative Manager and prior Zoning Administrator addressed the Board. Shared his reasoning for issuing a zoning permit for the lagoon. Believes the lagoon is a permitted use and/or accessory use to a farming operation in the Agricultural District. Receives water from livestock (agricultural in nature) trailer washout, a farmer uses the water to fertilize and water his crops (agriculture in nature).

Mr. Sullivan, Attorney for the Harvey's addressed the board for his final comments. He notices some loop holes by the business owner using many agencies against each other.

Moved to close the public hearing. by Hinrichs and seconded by Pirnie

Since his decision is being called into question, he doesn't want the look of impropriety.
